2. <u>AMENDMENTS</u>

- 2.1 Section 1.5 of the Amenities Fixed Fee Usage Agreement is amended to read as follows:
- 1.5 "Renewal Term"-shall mean and refer to the Renewal Term of this Amenities Fixed Fee Usage Agreement, which is April 15, 2011 to April 15, 2015.
- 2.2 Section 3.6 of the Amenities Fixed Fee Usage Agreement is amended to read as follows:
- 3.6 <u>Term.</u> This Agreement shall commence April 15, 2011 and remain in effect for a period of four (4) years, after which it shall be automatically terminated unless the BPOA and the BHOA mutually agree to the terms of any extension and/or renewal or it is terminated as provided herein. This Agreement may also be terminated at any time upon the mutual agreement in writing by both parties.
