CPMCA PROPOSED AMENDMENT TO THE BYLAWS

Proposal to Amend the CountryPlace Master Community Association, Inc. Amended and Restated Bylaws (August 2021), by adding a new Section 3.9.12 to Article III, as follows:

Any capital expenditure proposed by the CPMCA Board of Directors, shall not be acted upon without the approval of Fifty-one percent (51%) of the votes cast by Qualified Voters, as defined in Section 1.8 of the CPMCA Bylaws, who vote at a Special Meeting called for that purpose in accordance with Article II of the CPMCA Bylaws, if it will exceed thirty percent (30%) of the Capital Reserves as of the date of the proposal. This provision will not apply to any expenditure necessary to meet an emergency as determined by the Board by a vote of two-third (2/3) of the members of the Board, in an open meeting called for that purpose in accordance with Article III.

Proposal to Amend the CountryPlace Master Community Association, Inc. Amended and Restated Bylaws (August 2021), by adding the following sentence to Section 4.3. "Amendments" in Article IV, as follows:

The Board of Directors shall not have the power to amend the Bylaws other than in accordance with the provisions of this Section 4.3 of Article IV.
