The following Adoption of Working Capital Assessment is made pursuant to Section 6.4 of that certain <u>Declaration of Covenants</u>, <u>Conditions and Restrictions for Eastwood Green</u>, recorded under Document No. RP-2021-137874, in the Official Public Records of Harris County, Texas (the "**Declaration**"), by **URBAN INTOWNHOMES**, LTD., a Texas limited partnership ("**Declarant**"), and is as follows:

- 1. <u>Working Capital Assessment</u>. In accordance with *Section 6.4* of the Declaration, the Declarant adopts a working capital assessment amount equal to fifty percent (50%) of the Regular Assessments for the upcoming twelve (12) month period (the "Working Capital Assessment"). The Working Capital Assessment applies to all Lots subject to the Declaration unless otherwise exempt pursuant to *Section 6.4* of the Declaration.
- **2. Subject to Change.** The amount of the Working Capital Assessment designated hereunder is subject to change from time to time by the Declarant, until the expiration or termination of the Development Period, and the Board thereafter.
- 3. <u>Capitalized Terms</u>. Capitalized terms used but not defined herein shall have the meanings ascribed to such terms in the Declaration.
