**ARTICLES OF INCORPORATION  
OF  
PARK AT MEADOWGLEN HOMEOWNERS ASSOCIATION** Corporations Section

**ARTICLE ONE**

The name of the Corporation is Park At Meadowglen Homeowners Association, Inc.

**ARTICLE TWO**

The corporation is a non-profit corporation.

**ARTICLE THREE**

The period of its duration is perpetual.

**ARTICLE FOUR**

The specific and primary purposes for which the Corporation is organized and formed under the laws of the State of Texas are (i) the collection, expenditure and management of maintenance assessments provided for in any Declaration of Covenants, Conditions and Restrictions as amended from time to time ("Declaration"), to which a planned residential development in Harris County, Texas, known as Park At Meadowglen is subject, (ii) the enforcement of the Declaration, (iii) providing for the maintenance, preservation and architectural control within Park At Meadowglen set forth in the Declaration, (iv) operating, maintaining and improving the Driveway Easement (as defined in the Declaration), and (v) the general overall supervision of all of the affairs of such development and the promotion of the general welfare of the residents within Park At Meadowglen.

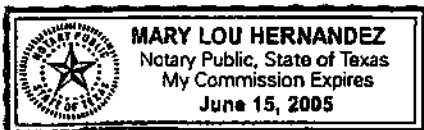
