AMENDMENT TO THE BYLAWS OF <u>RIVER PLANTATION COMMUNITY IMPROVEMENT ASSOCIATION, INC.</u>

WHEREAS, River Plantation Community Improvement Association, Inc. (the "Association"), a Texas nonprofit corporation, is the governing entity for River Plantation Subdivision, which consists of the Property described in Exhibit "A", attached hereto (the "Property"); and

WHEREAS, the Association Bylaws are recorded in the Real Property Records of Montgomery County, Texas, under Clerk's File No. 2011-113002, along with the Amendment to the Bylaws recorded under Clerk's File No. 2014-091800 (the "Bylaws"); and

WHEREAS, pursuant to Business Organizations Code § 22.102(c), the Association Board of Directors may amend the Bylaws; and

WHEREAS, the Association's Articles of Incorporation do not reserve the power to amend the Bylaws exclusively to the corporation members, the management of the corporation is not vested in its members, and the members have never amended the Bylaws to expressly provide that the directors may not amend the Bylaws; and

WHEREAS, the Association, through its Board of Directors desires to amend the provisions of the Bylaws to provide for staggered terms for directors, to require that all directors must be members of the Association and to require that only directors may serve as officers;

NOW THEREFORE, pursuant to the foregoing and as evidenced by the Certification of the Association President hereto, the Association Bylaws are hereby amended to read as follows:

Article V "Board of Directors", Section 1 "Number and Term of Office", the second paragraph, which had previously read:

The number of directors shall be nine (9) provided that the number may be increased or decreased by an amendment to these Bylaws. At the 2015 annual meeting two (2) directors shall be elected to serve initial three (3) year terms, and two (2) directors shall be elected to serve initial two (2) year terms. At the 2016 annual meeting, three (3) directors shall be elected to serve initial three (3) year terms and two (2) directors shall be elected to serve initial two (2) year terms. As these initial terms expire, each director position shall then be filled for terms of three (3) years.

Is hereby amended to read as follows:

The number of directors shall be nine (9) provided that the number may be increased or decreased by an amendment to these Bylaws. At the 2015 annual meeting two (2) directors shall be elected to serve initial three (3) year terms, and two (2) directors shall be elected to serve initial two (2) year terms. At the 2016 annual meeting, two (2) directors shall be elected to serve initial three (3) year terms and one (1) director shall be elected to serve an initial two (2) year term. At the 2017 annual meeting, one (1) director shall be elected to serve an initial three (3) year term and one (1) director shall be elected to serve an initial three (3) year term. As these initial terms expire, each director position shall then be filled for terms of three (3) years.

Article V "Board of Directors", Section 1 "Number and Term of Office", *the first paragraph*, which had previously read:

The business and property of the Corporation shall be managed and controlled by the Board of Directors, and subject to the restrictions imposed by law, by the charter, or by these bylaws, the Board of Directors may exercise all of the power of the Corporation.

Is hereby amended to read as follows:

The business and property of the Corporation shall be managed and controlled by the Board of Directors who shall all be Members of the Association, and subject to the restrictions imposed by law, by the charter, or by these by-laws, the Board of Directors may exercise all of the power of the Corporation.

Article VI "Officers", Section 1 "Titles and Term of Office", which had previously read:

The officers of the Corporation shall be a President (who shall be a director), Vice President, a Secretary, a Treasurer and such other officers as the Board of Directors may from time to time elect or appoint. One person may hold more than one office. All officers shall be subject to removal, with or without cause, at any time, by vote of a majority of the whole Board of Directors. A vacancy in the office of any officer shall be filled by vote of a majority of the directors then in office.

Is hereby amended to read as follows:

The officers of the Corporation shall be a President, Vice President, a Secretary, a Treasurer and such other officers as the Board of Directors may from time to time elect or appoint. All officers shall be directors of the Association. One person may hold more than one office. All officers shall be subject to removal, with or without cause, at any time, by vote of a majority of the whole Board of Directors. A vacancy in the office of any officer shall be filled by vote of a majority of the directors then in office.
