

AMENDMENT TO RESTRICTIONS

**DEEDS**

RIVER PLANTATION, SECTION FOUR

THE STATE OF TEXAS }  
COUNTY OF MONTGOMERY }

WHEREAS, on the 29th day of May, 1968 WALTER M. MISCHER CO., TRUSTEE and TENNESSEE LIFE INSURANCE COMPANY executed certain building restrictions in connection with a certain subdivision known as RIVER PLANTATION, SECTION FOUR; and

WHEREAS, said restrictions were placed of record in Volume 663, Page 854 of the Deed Records of Montgomery County; and

WHEREAS, in Paragraph #1 of said restrictions, the word "and" was omitted from the paragraph thereby creating uncertainty as to the meaning of said paragraph:

NOW, THEREFORE, KNOW ALL MEN BY THESE PRESENTS: THAT the undersigned do hereby amend and correct said restrictions as to Paragraph 1 and that said paragraph will now read as follows:

1. BUILDING SITE

As used in these restrictions, the term "building site" means all or a part of any one or more numbered lots in River Plantation, Section Four, provided that, in the event lots are resubdivided, the width at the front building line is not less than seventy-five (75) feet and that the area shall be not less than nine thousand (9,000) square feet.
