Nothing herein contained is intended or shall be construed to amend such Declaration other than to add and annex additional land as stated herein.

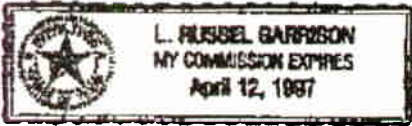
